**From West - Mass. Tpk.**

(Rt. 90) East to 495 South to exit 15.

**Acknowledgement of Entries** will be made as soon as practical after entries have closed. Should such acknowledgement not be received by exhibitor within a reasonable time, please notify Show Secretary.

**Telephone, Telegraph and Unsigned Entries cannot be Accepted. Entries Not on Official AKC Entry Forms and Photocopies of Entry Forms** without the Agreement and Rules on the reverse side of the official AKC entry form are not acceptable.

**No Entry** shall be made and no entry shall be accepted which specifies any condition to its acceptance.

**Entry Fee Will Not Be Refunded** in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Show Committee. If, because of riots, civil disturbance or other acts beyond control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.

**Entries cannot be accepted, cancelled, altered or substituted** after entries have closed, except as provided for in Chapter 14, Section 1 of the Dog Show Rules.

**An AKC recording fee** of \$.50 first entry only and an AKC Event Service Fee of \$3 per entry will be required for each dog entered at any Licensed Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3 will be required for each entry in any Licensed or Member Club Rally Trial (American Kennel Club Rules, Chapter 11, Section 2). All such fees are paid to the AKC.

**No Refund For Duplicate Entries.** We will make every effort to find all duplicate entries but if an entry has been processed, no refund will be made.

**Returned Checks** do not constitute a valid entry fee. The Show Secretary will add a \$35.00 collection fee to each returned check.

**Consult Judging Program For Time Of Judging.** Show hours are from 8:00 a.m. to 5:00 p.m.

**Dogs May Arrive** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

**Judges Are Not Required To Wait for Dogs.** They will adhere as closely as possible to the judging schedule.

**Only Dogs That Are Eligible To Be Shown** under AKC rules shall be allowed within the show precincts. The owners or agents shall be responsible for the care and safety of such dogs (Ch. 14, Sec. 11, Dog Show Rules)

**Dogs Which, According To Their Owners' Records,** have completed the requirements for a Championship after the closing of entries for the show, but whose titles are unconfirmed, may be transferred from one of the regular classes to the Best Of Variety Competition, provided this transfer is made at least one half hour prior to the start of any regular conformation judging at the show.

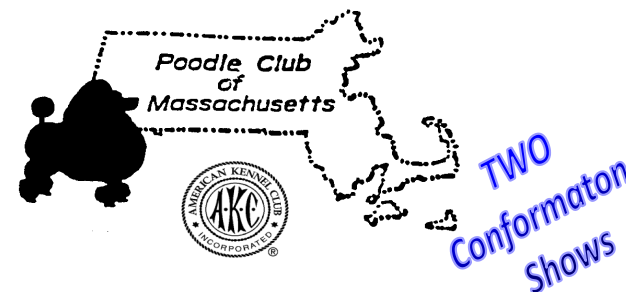

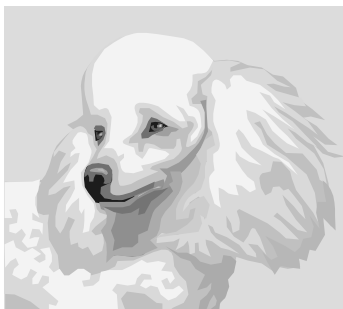
