

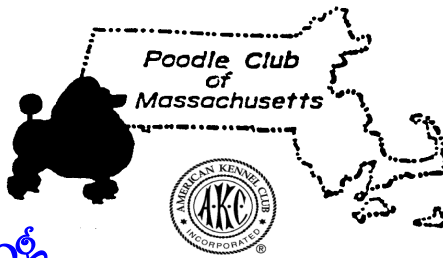

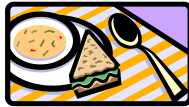

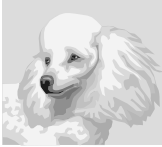

NOTICE: In order to provide Overnight Parking, the Center mandates that the Ladies' Dog Club, Inc. provide police protection throughout, that overnight parking be by **reservation only** and that the parking is controlled in **designated areas only**. Those not abiding by the following rules are subject to removal and possible Event Committee penalties!

FRIDAY SPECIALTIES ONLY: Overnight parking is available from **3:00 P.M.** until **10:00 P.M.** Thursday, May 30, and during the stated hours of the Friday Specialties. Overnight vehicles may remain until after BIS on Sunday, June 2, provided you fill out and send the **general overnight Parking Form** ([page 6](#)) and the required **\$75.00** fee. Send the **Specialty Parking fee of \$25.00** (checks made payable to Ladies' Dog Club) to Rick Krieger, 84 Smith Road, Charlton, MA 01507 (781) 771-0022 E-mail: K9Racer82@aol.com. **You MUST park in designated areas ONLY!**

GENERAL OVERNIGHT PARKING for Fri and Sat nights, May 31 & June 1, 2013, from **12:00 Noon** until **10:00 P.M. closing**. Gate opens at 6:00 A.M. on Saturday for General Admission and Parking.

- **Reservations will be held ONLY until 9:00 P.M. on Friday, May 31, 2013.**
- All units must be self-contained. No camper hookups.
- Vehicles with dogs **MUST NOT** be left unattended overnight.
- Overnight Parking in designated areas ONLY.
- **Firelanes** must be maintained.
- FEE for Reserved Parking is \$50.00 per MOTOR VEHICLE and covers both Friday and Saturday nights.(Additional \$25 for Thursday)

NOTE: there will be a late fee of an additional \$5.00 per night for those arriving without reservations made prior to the **May 28 deadline. No exceptions!**

- * • **No holding of space** - coming "in together" is the only way of "staying together".
- * All trash **MUST** be placed inside **CLEAN** plastic bags and placed in available barrels. PLEASE do your part in keeping this site available to us!

DIRECTIONS TO THE SHOW GROUNDS

Crackerbarrel Fairgrounds, Wrentham, Ma

From Rt. 95 North and South - Exit 6B to 495 North to Exit 15 (Rt. 1A).

At end of ramp follow Route 1A North for 3 miles; stay on Rte 1A; go past the intersection of Rt. 140. Take left at blinking yellow light (North St.). First left on Emerald Street to show grounds.

From West - Mass. Tpk.

(Rt. 90) East to 495 South to exit 15.

Take left at end of ramp, follow directions above.

Notice to Exhibitors

Acknowledgement of Entries will be made as soon as practical after entries have closed. Should such acknowledgement not be received by exhibitor within a reasonable time, please notify Show Secretary.

Telephone, Telegraph and Unsigned Entries cannot be Accepted. Entries Not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side of the official AKC entry form are not acceptable.

No Entry shall be made and no entry shall be accepted which specifies any condition to its acceptance.

Entry Fee Will Not Be Refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Show Committee. If, because of riots, civil disturbance or other acts beyond control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.

Entries cannot be accepted, cancelled, altered or substituted after entries have closed, except as provided for in Chapter 14, Section 1 of the Dog Show Rules.

An AKC recording fee of \$.50 first entry only and an AKC Event Service Fee of \$3 per entry will be required for each dog entered at any Licensed Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3 will be required for each entry in any Licensed or Member Club Rally Trial (American Kennel Club Rules, Chapter 11, Section 2). All such fees are paid to the AKC.

No Refund For Duplicate Entries. We will make every effort to find all duplicate entries but if an entry has been processed, no refund will be made.

Returned Checks do not constitute a valid entry fee. The Show Secretary will add a \$35.00 collection fee to each returned check.

Consult Judging Program For Time Of Judging. Show hours are from 8:00 a.m. to 5:00 p.m.

Dogs May Arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Judges Are Not Required To Wait for Dogs. They will adhere as closely as possible to the judging schedule.

Only Dogs That Are Eligible To Be Shown under AKC rules shall be allowed within the show precincts. The owners or agents shall be responsible for the care and safety of such dogs (Ch. 14, Sec. 11, Dog Show Rules)

Dogs Which, According To Their Owners' Records, have completed the requirements for a Championship after the closing of entries for the show, but whose titles are unconfirmed, may be transferred from one of the regular classes to the Best Of Variety Competition, provided this transfer is made at least one half hour prior to the start of any regular conformation judging at the show.
